

CEINEX Bond Market

Main prerequisites for participation and follow-up obligations

CEINEX provides services for listing debt instruments related to China, based on existing DBAG infrastructure and within EU regulation. Bond issuance and listing requirements are same as that of DBAG. Two different market segments could be chosen for issuers to list RMB bonds and Non-RMB bonds.
